CLK 1009/AIUDP towards the cost of project for Anuradhapura Integrated Urban Development Project (AIUDP) and intends to apply part of the proceeds of this loan to payments under the above Contract.

The Services has included to engage a Consultant for Independent Monitoring and review of the Social Safeguard implementation program to determine whether intended goals are being achieved and if not, what corrective actions are needed. The assignment includes monitoring and reviewing of various Social Safeguards associated with the land acquisition, resettlement and rehabilitation compensation, resettlement action plans, information disclosure and communication etc for AIUDP.
